Sir,

I am directed to refer your letter No. Aff-Regc-3161  
dated 19.3.1980 on the above subject and to inform you that upon  
consideration of the applications received by the Government,  
through your University, the State Government has no objection  
to the processing of the following applications moved for opening  
of new Colleges, under Section 43(A) of the Bombay University Act,  
1974.

2. In this connection, I am further desired to add that,  
in view of the short time available now, the State Government would  
have no objection to your University presuming that should the  
University decide to recommend grant of affiliation to any of the  
Colleges referred to above the State Government would issue an  
order in due course, in terms of Section 43 (7) of the Bombay  
University Act, 1974, granting affiliation accordingly. Such  
grant of affiliation will, however, be subject to the following  
conditions:-

- i) The College must have minimum enrolment of 40 students  
in each faculty in which it has been permitted to  
impart instructions for the First Year of the Degree  
Course.
- ii) Not less than 30 students should appear for the  
University Examinations held at the end of the  
academic year 1980-81.

3. It is suggested that the Vice-Chancellor of your  
University may kindly consider permitting, in exercise of his  
emergency power, the colleges under reference to be opened from  
the beginning of the forthcoming academic year due to begin

in June-July 1980, subject to such conditions as he may deem necessary to impose in the context of the Bombay University Act, 1974. While communicating such permission to the Management, it may be informed unequivocally that enrolment of Students for admission to faculties permitted to be opened should start only on provisional basis. If at least 40 students enrol for admission, then, and then only, the admissions may be confirmed and the College actually started with such faculty (or faculties). If a minimum number of 40 students do not enrol for admission that faculty should not be opened at all. Further the College should be informed that in the event of less than 30 students appearing at the annual University Examination to be held in April-May 1981, the Management will not be considered eligible for grant-in-aid from Government during 1981-82 and that it would be required to close down the concerned faculty or faculties.

With the adoption of monthly salary payment scheme from the  
year 1981-82, this Directorate has been releasing monthly salary  
grants to the Non-Government colleges of Arts, Science, Commerce  
and Education in the State to meet their salary requirements for  
the month with due regard to the rise in expenditure, as a  
result of increased rates of D.A., annual increments of the staff  
and other salary payments etc. According to the grant-in-aid  
rules, 10% of income i.e. released from the fee paying students  
has been allowed to be kept with the college in the salary payment  
account to meet the salaries expenditure. It has been the practise  
that this Directorate has been releasing salary grants to meet  
the full requirements for the months of March, April, May and  
June and thereafter while releasing the salary grants, 1/6 of the  
10% income by way of tuition fees from the fee paying students  
has been deducted at source from the salary grants released by this  
Directorate. This procedure is being followed since last year and  
the 1/6th instalment is released in February after adjustment of the  
10% fee income that is reported by the Administrative  
Officers. According to this practise, the Directorate has already  
released salary grants from March 1982 to June 1982 on 100% basis  
after deduction of 1/6th of the salary grant for July 1982 has now  
been released to the Non-Government colleges after deduction of 1/6th of the  
salary grant on the assumption that the college would earn fee  
income during 1982-83, equal to that of the last year. This procedure  
will be continued till the figures of final assessment are reported  
by the Administrative Officer, Higher Education Grant of the Region.

While releasing the salary grant for the month of July,  
the following considerations have also been taken into account.

- 1. Government have granted increase in the rates of D.A. as  
per Government Resolution, Finance Department No. CPA 1182/GR-292/  
SPR-7, dt. 15.4.1982. The rise in D.A. on four occasions as  
mentioned in the Government Resolution has been taken into  
consideration for the release of monthly salary grants for July  
1982.

2. It is just possible that in case of some college the 1/6th of the fee income as per last year's collection is likely to be much more than the monthly salary payment (including the D.A. also as mentioned above) and the requirements of surrender leave benefits etc. In all such cases, this Directorate will not be releasing an addition amount for these purposes on the monthly salary grant from July 1982 onwards. The Principals of all such colleges are hereby directed that, all the fee income from fee paying students including the fee income of Government of India's concessions for backward class students, etc. should necessarily be credited to the salary payment account of the college and the monthly salary expenditure should be not withdrawn from these balances.

3. In case however, if any shortfall is experienced by such colleges referred to at Item No. 2, where the fee income is utilized for salary grants, the Principals are requested to make separate references to the Directorate through the Administrative Officers for the additional requirements to cover the salary payments. These cases will be scrutinised on merits of each case and the additional grants will be released to them.

4. In regard to the non-salary grants, the first instalment has been released equal to 4% of the estimated salary expenditure for the year 1981-82 or to the extent of the last year's salary grant whichever is less. This may please be noted.

It has also been noticed by the Directorate that number of references are received by the Administrative Officers as well as this Directorate for additional funds to meet the salary expenditure. If the colleges work out their realistic estimates (excluding the inadmissible expenditure) on which the grants are released by the Directorate - (minus) the income by way of fee paying students, it is expected that there will be no occasion for the college to face the shortfall in the salary expenditure and all such correspondence can be easily eliminated.

"O.2802 : Admission of students against the sanctioned seats in the various classes in the colleges shall be made on the basis of merit only and no donation or capitation fee or deposit of any kind shall be charged by management of any college or a college for admission of students against these seats. The management of college or colleges shall accept fees and other charges as prescribed by the University for admission of students against these seats.

If the management of any colleges or a college is permitted by Government and/or University to admit students at its discretion to the extent of the number of seats fixed by Government and/or University, the Management/College shall not accept any donation or capitation fee or deposit of any kind in respect of admission against these seats."

The amended Ordinance 2802 has come into force with effect from 1st December, 1986.



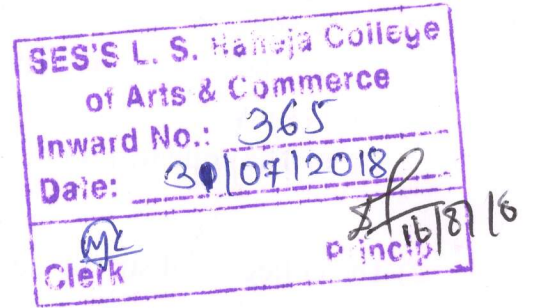

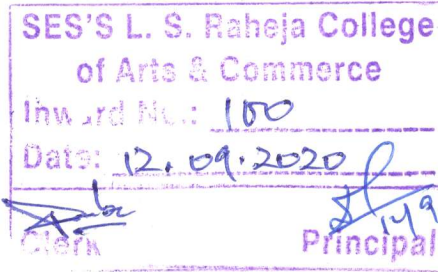
