

MINUTES OF THE MEETING

1. CA. Hrishikesh Wandrekar called the meeting to order and welcomed all members present for the Board of Studies meeting for Accountancy and Finance.
2. Leave of absence was granted to CA. Mangesh Kinare, CA. Vaibhav Banjan, CA. Gagan Singh Dr. Vaishali Pandya, Mr. Raju Gole Ms. Sampada Almeida, and Mr. Tejas Pednekar.
3. The agenda for the meeting was unanimously approved, ensuring a structured and focused discussion.
4. CA. Hrishikesh Wandrekar gave brief overview of NEP structure of M.Com and explained position of Accountancy and Finance papers in that structure.
5. The syllabus of accounting courses of Semester II M.Com in Advanced Accounting and M.Com in Banking & Finance and OJT guidelines was presented by CA. Hrishikesh Wandrekar.
6. The Board discussed the examination structure for the 2 and 4 credit courses and approved the same.
7. The Board considered and approved the eligibility criteria of various programmes.
8. CA. Dr. Jayant Apte suggested to exclude nature and scope of cost accounting and to consider inclusion of standard costing from the syllabus of Advance cost Accounting. The same was considered and accepted by the Board.
9. CA. Dr. Jayant Apte and CA. Dr. Varadraj Bapat suggested that the syllabus should include advanced concepts of GST as a progression to what has been covered at the undergraduate level. They further suggested that students who might not have studied GST at undergraduate level could learn the basic concepts through SWAYAM courses.
10. CA. Dr. Jayant Apte recommend keeping risk management as a separate module as a part of Strategic financial management II course of MCOM.
11. Mr. Vijay Paradkar recommend that teaching pedagogy should include interpretation and analysis of financial statements, financial ratios and inter play of various ratios.
12. Mr. Vijay Paradkar suggested to add comparison between IFRS and GAAP as a part of Introduction to Indian Accounting Standards course.
