ITEM NO.1: Introduction and welcome of Committee Members.

Mr. Ashish Samant, Member Secretary welcomed all the members and introduced them.

ITEM NO.2: To approve revise fee structure of all existing programmes (aided and unaided) for 2024-25

In the meeting it was decided to revise mainly Examination fee and Add On Course fee for the aided programmes.

1. The increase in fee is due to implementation of autonomy and NEP whereby number of courses have increased and all examinations have to be conducted by the college.
2. In case of unaided programmes mainly Examination fee and Tuition fee have been revised.

Revised fee structure as per Annexure. I

ITEM NO. 3: To approve of fee structures of following new programmes for 2024-25.

(A) **B.COM (Management Accounting & Finance) with CMA (USA)**:-Being a professional course 55% of lectures will be taken by CMA professionals through FPA (Financial Planning Academy) whereas the college will be taking workload of 45%. Hence the proposed fee for this programme will be INR 85,000/-which will be shared between college and FPA the percentage of fee sharing will be mutually decided. The intake capacity of students will be 60 students. One full time teacher will be appointed for the programme.

(B) **M.A Psychology - Clinical specialisation**.-This is specialised programme whereby only 24 students will be admitted, majority of the lectures will be taken by professional visiting faculties. One full time teacher will be appointed for the programme.

Proposed fee for this programme is INR 70,000/-

Both the fee will be reviewed in the year 2025-26.

Item no -4 :- To approve of draft refund of fees regulation from 2024-25.

Member Secretary presented draft Regulation of fee refund which is to be implemented for 2024-25.

The draft Regulation of fee refund 2024-25 approved and accepted.



